

### Claims - Process Roles & Responsibilities



- 1. Provide clarity on changes to high level process, roles and responsibilities to aid market adoption
- 2. Concentrating on the "who", the "what", and the "when". (The "how" remains at the discretion of market participants and solution providers
- 3. Work with the market to validate operational assumptions, market terminologies and ensure that the final output aids adoption
- 4. For claims specifically the scope is to document the changes in roles and responsibilities for the market.
